Carlos Palanco, 117 Orchard St., appeared to speak and stated that this business's patrons and employees have nowhere to park. He has called the Police numerous times to clear this up. This makes it very difficult to commute in and out of the neighborhood. He also stated that constant trash is coming down the street from the dumpster. There is no effort from their part to keep the neighborhood clean. There should be some responsibility on their part to keep the neighborhood safe and clean and he does not see that happening at all.

Council Vice-President Favicchio asked what the hours of operation are. Mr. Alcantara stated that the hours are 8:00 A.M. to 8:00 P.M. Council Vice-President Favicchio asked how many seats are in the establishment. Mr. Alcantara stated 24.

Mr. Palanco stated that he does not have a problem with them expanding the business, but when he does not see them help the community, how can he agree to expanding their business?

Chair asked applicant how many years they have been in operation at this location. Mr. Alcantara stated five years. Chair asked how many times a week the dumpster is picked up. Mr. Alcantara stated two times a week. He also stated that some of the trash is from people dumping their trash in the dumpster. Ms. Calcano has indicated to him that she can add a larger dumpster.

Councilmember Stycos stated that most dumpsters can be locked.

Councilmember Vargas asked that the Administration check to see if there is a "No Parking" sign from this business to the corner of Park Ave. and if not, she asked that the Traffic Engineer look at it and maybe have one installed. This may resolve some of the parking issues the neighbor has. She also suggested that the applicant lock the dumpster at night. She suggested that if this is approve this evening, the applicant be asked to appear back before this Committee in a month or so to see how things are going and if there are any more problems.

Motion and second to approve this license were withdrawn.

On motion by Council Vice-President Favicchio, seconded by Councilmember Brady, it was voted to approve this license with a three month review and applicant be asked to appear at the November meeting. Motion passed unanimously.
