NOTICE OF PUBLIC HEARING
“Kelly Plat”
Minor Subdivision with Zoning Relief
Unified Development Review

You are hereby notified that the Cranston City Plan Commission will meet to review the Preliminary Plan for a proposed Minor Subdivision entitled **“Kelly Plat”**. This public hearing will be held on **Tuesday, October 6, 2026, at 6:30 P.M.**, in the Council Chambers, Cranston City Hall, 869 Park Avenue, Cranston, Rhode Island. You are invited to attend this public hearing at which time plans will be presented for public comment and City Plan Commission consideration.

In accordance with the provisions of RIGL §45-23-50.1 and §45-24-46.4 (Unified Development Plan Review), the City Plan Commission will consider and vote upon any requested zoning relief in lieu of the Zoning Board of Review for subdivisions and land development projects. The Proposal requires relief from provisions of the Zoning Ordinance including Chapter 17.20.120 – Schedule of Intensity Regulation relating to the street frontage requirement of 60 feet and the lot size requirement of 6,000SF.

The subject parcel is located at 17 Bulter Street, Lot No. 559 on Assessor’s Plat No. 11 and contains approximately 17,500 sq. ft +/- . The owners are Patrick Kelly and Lauren Gottfried-Kelly and the applicant is Patrick Kelly. The proposal seeks to subdivide the existing lot into two lots which will contain 12,393 sq. ft. and 5,107 sq. ft. Both lots will front on Butler Street. The subject parcels are zoned B-1 Single/Two-Family Residential (6,000SF/8,000SF). Parcel A, with the existing dwelling, will not require relief. Parcel B, proposed for single-family development, will require relief to have 53 feet +/- of street frontage and a lot size of 5,107 sq. ft. The proposed single-family dwelling is a use allowed by right within the Cranston Zoning Code, subject to the dimensional zoning relief sought. The new lot will be serviced by public sewers and water.

The application may be reviewed prior to the meeting in the City Planning Department, Room 309, Cranston City Hall, during regular office hours, 8:30 A.M. – 4:30 P.M., Monday through Friday.

Pursuant to the Cranston Subdivision and Land Development Regulations, the proposed plan may be revised by the City Plan Commission because of further study or because of views expressed at this meeting.
