If a candidate for state or local office, I hereby certify that I have not within the preceding three (3) years served any sentence, incarcerated or suspended, on probation or parole, for a crime committed after November 5, 1986 upon a plea of nolo contendere or guilty or upon a conviction of a felony or for a misdemeanor for which a sentence of imprisonment for six (6) months or more, whether suspended or to be served was imposed.

By signing and filing this Declaration of Candidacy, it is my express intention to withdraw any and all declarations of candidacy that I previously filed for any state or local public office during this current declaration period. I do so with full knowledge that any previously filed Declaration of Candidacy shall become null and void.
