LANDSCAPE PLAN

Landscaping Guidelines

Use plant material that tolerates dry, poor soils, requires less water than most, and requires a minimum of maintenance. Limited susceptibility to insect and disease infestation and tolerance to salt exposure are desirable traits. Use peat moss, manures or other organic matter as soil amendments to improve soil structure and increase water-retentive properties of soils. Use bark or other mulches to aid in retaining soil moisture. Limit use of fertilizer to avoid overstimulating plant growth which in turn increases water requirements. Please employ proper watering practices, especially during establishment period. Water deeply to soak root zone and force roots to go deep.

Planting Guidelines

Please abide by the follow rules for planting, notify **Dig Safe** and attach a copy of your **Insurance Liability form**.

Clearance from the Edge of the Travel Lane

- A. Curb or Guardrail: 5' clearance necessary
- B. Wildflower Plantings: No clearance necessary
- C. Without Curb or Guardrail:
 - i. 55 MPH- 30' from edge of travel lane
 - ii. 45 MPH – 20'
 - iii. 35 MPH – 15'
 - iv. 25 MPH – 15'

Planting Heights

- A. Median: No trees or shrubs with caliper 4" or greater
- B. Island: Ultimate heights of shrubs no greater than 3'
- C. Trees: Lowest branches higher than 6'- 8' from sidewalk
- D. Sidewalk Clearance: Minimum of 3' width needed for passage of wheelchairs
- F. All Calculations: Measured according to AASHTO guidelines
