1. Applicant shall make his/her application at the City Clerk's Office at Cranston City Hall 869 Park Avenue, Cranston, RI 02910. ****Include copy of driver's license.**
2. The applicant shall furnish the City Clerk for the Safety Service & License Committee with an accurate location plat or plan. Plan shall
Be a copy of the Assessors plat, drawn to scale and shall show the Assessors lot
Numbers of all lots or parcels within 200 feet of such building or place.
3. The applicant shall furnish a list to the City Clerk of all Assessors lot numbers
Of the lots or parcels within a radius of 200 feet with the NAMES AND ADRESSES
OF THE TAXED OWNERS THEREOF AS RECORDED IN THE LATEST TAX
BOOK OF THE TAX ASSESSOR AND MUST BE IN TYPEWRITTEN FORM.
4. THE APPLICANT MUST SHOW AN APPROVED ZONING CERTIFICATE FROM
THE LOCAL BUILDING/ZONING OFFICIAL LOCATED @1090 CRANSTON
STREET.
5. Application requires advertising 3 times in the local newspaper. This
application is a public hearing application and has to be filed in a timely fashion and
advertised accordingly to meet the deadline for the next available public hearing. You
will be advised of the available hearing date at the time of filing.
