FLOWER VENDOR

REQUIREMENTS FOR OBTAINING A FLOWER VENDOR APPLICATIONS

1. Applicant MUST apply for application in person.
2. Applicant MUST provide a letter of permission from the property owner stating that they authorize the use of their property for sale of the flowers.

REQUIREMENTS FOR OBTAINING FLOWER VENDOR LICENSE

1. Applicant MUST appear before the Committee on Safety Services and Licenses. The next meeting of the Committee is scheduled for _____ At 6:00 PM in the Council Chambers at City Hall.
2. Flower Vendor License and any additional licenses required by the Code of the City of Cranston MUST be issued PRIOR to the sale of any flowers.

RESTRICTIONS ON THE SALE OF FLOWERS

1. Flower Vendor MUST observe rules regarding sales no closer than 1000' from an established flower business.
2. Flower Vendor MUST be 300' away from major intersections.
3. Flower Vendor MUST be 300' away from places of worship during, one-half hour before and one-half hour after services.
4. Flower Vendor MUST provide a radius map from the Tax Assessors' Dept. along with the application to show proof of complying with all the above restrictions and proof of ownership of the property to verify that the letter of permission in fact is from the property owner.
5. Failure to adhere to ALL requirements specified "Flower Vendors" in sections 21-16 thru 21-23 of the Code of the City of Cranston may result in the "Flower Vendor" License being suspended or revoked.
