## APPLICATION FOR USED CARS

1. APPLICANT MUST OBTAIN A ZONING CERTIFICATE FROM THE BUILDING INSPECTOR (1090 CRANSTON STREET)
2. APPLICANT SHALL OBTAIN A 200 FEET RADIUS MAP AND A LIST OF ALL ASSESSOR'S LOT NUMBERS OF THE LOTS OR PARCELS WITH THE NAMES AND ADDRESSES OF THE TAXED OWNERS. A SET OF MAILING LABELS IS REQUIRED
3. MUST BE SUBMITTED TO THE CITY CLERK'S OFFICE 21 DAYS BEFORE THE NEXT SAFETY SERVICES AND LICENSES COMMITTEE MEETING
4. \$80.00 ADVERTISING FEE
5. MUST PRESENT A SITE PLAN TO THE TRAFFIC ENGINEER SHOWING THE LOCATION OF THE BUILDING, SURROUNDING STREETS, INGRESS AND EGRESS TO THE PROPERTY, CURB CUTS, PARKING AND HANDICAP PARKING, PLEASE INDICATE WHERE THE BUILDING WILL BE AND WHERE THE AUTO REPAIR IS AND WHERE THE USED CARS WILL BE AS WELL AS SIGN LOCATIONS AND LIGHTING.
