**PROJECT NARRATIVE**

This project narrative is offered in connection with application of Gary Fletch LLC (“Owner/Applicant”) for permission to utilize a vacant lot on Fletcher Avenue for motor vehicle storage.

The subject property is designated as Lot No.2847 on Assessor’s Plat No. 12/2 and is in a B-1 zone. The lot contains 10,984 square feet. A portion of the property is in a flood zone.

Plans call for the lot to be fenced in from the adjoining properties.

The following relief is sought from these sections of the zoning code.

17.20.030 Schedule of Uses

Motor vehicle storage is not permitted in any zoning district.

17.20.120 Schedule of Intensity Regulations

Lot has fifty-eight (58) feet of frontage where sixty (60) feet of frontage is required in a B-1 zone.

17.92.010 Variance

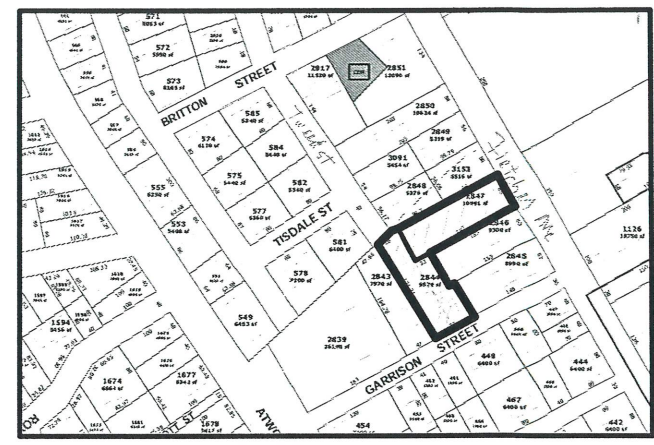
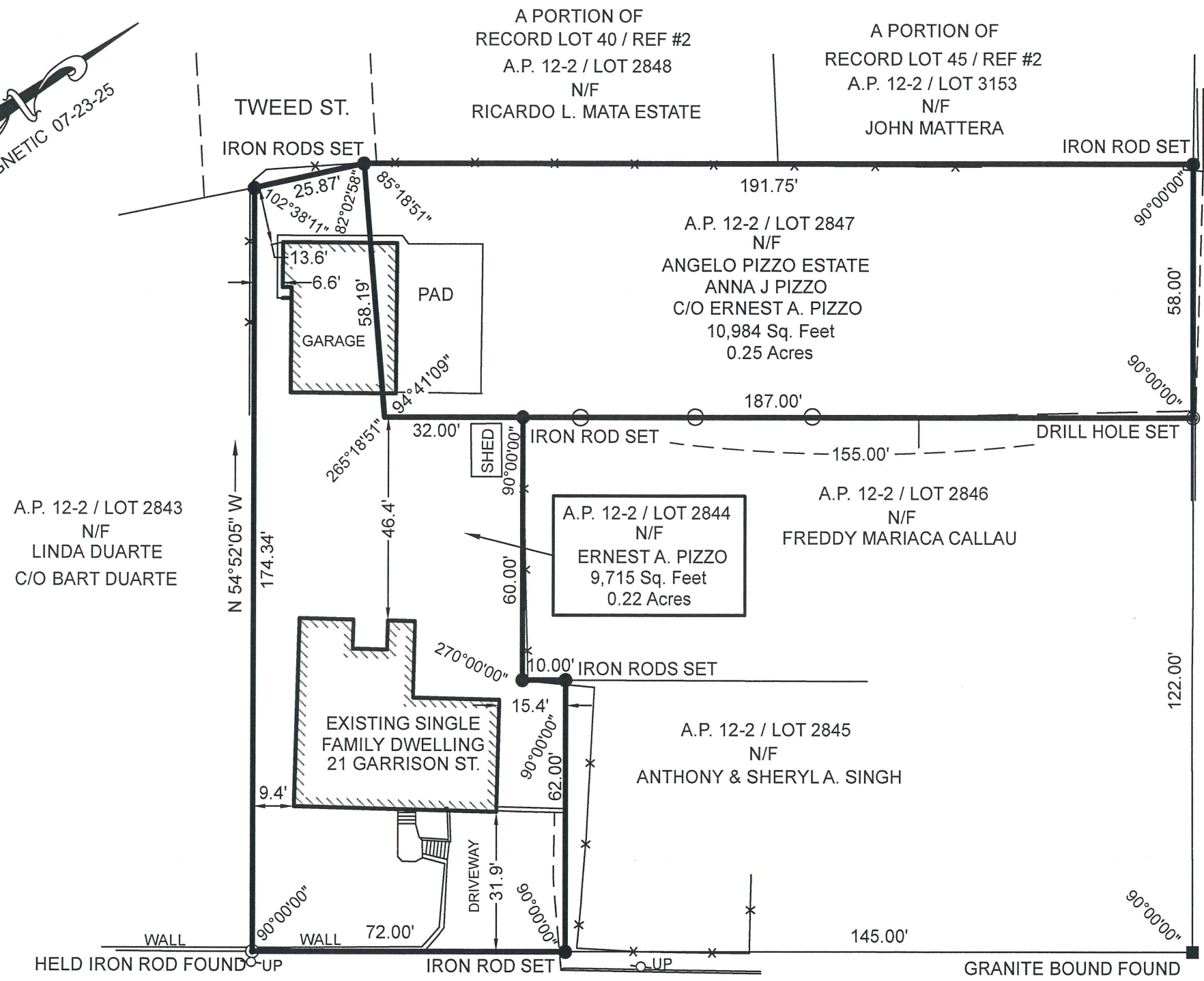
Dimensional Variance

The hardship from which the applicant seeks relief is due to the unique characteristics of the subject land or structure and not to the general characteristics of the surrounding area; and is not due to a physical or economic disability of the applicant;

The hardship is not the result of any prior action of the applicant and;

The granting of the requested variance will not alter the general character of the surrounding area or impair the intent or purpose of the zoning ordinance codified in this title or the comprehensive plan upon which the ordinance is based.

That the hardship suffered by the owner of the subject property if the dimensional variance is not granted amounts to more than a mere inconvenience, meaning that relief sought is minimal to a reasonable enjoyment of the permitted use to which the property is proposed to be devoted.

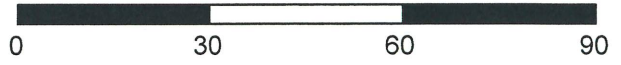

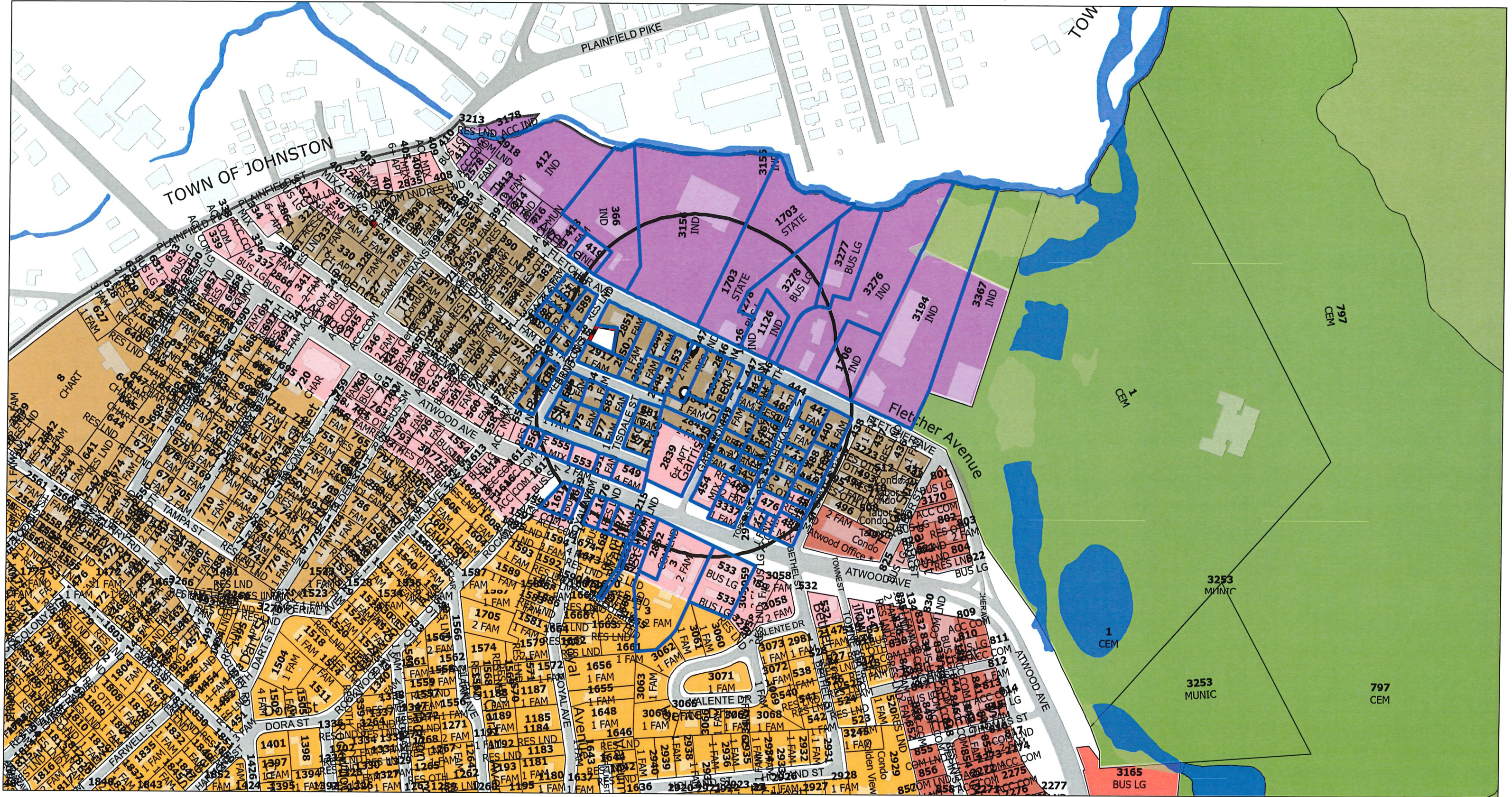

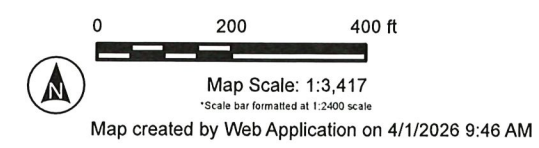
